CONTINUATION OF REPORT

Report No. L/20211208/2001

On the 26.03.2018, I was charged before a Magistrate in an Immigration Session Court and fined RM30,000/-. I paid the fine on the same day and the court gave me an Order of Discharge for my release. See Attachment 2 - Order of Discharge.

Instead of releasing me, Muhammad Hanis Bin Kasni, Harifah Binti Busu, Mohd Zain Bin Mohd Ali and Prem Singh continued to lock me up against my will. This extrajudicial detention from 26.03.2018 to 04.04.2018 is a continuation of an illegal and unconstitutional detention.

During this period of 26.03.2018 to 04.04.2018, I was locked up in Kluang Prison for a few days and then transferred to the cruel and inhumane Pekan Nanas Immigration Depot for illegal immigrants.

I am not an illegal immigrant as I have a valid "Make Malaysia My Second Home" (MM2H) visa and my Singapore Passport with me. See Attachment 3 - Valid MM2H visa and see Attachment 4 - Valid Singapore Passport. See also Attachment 5 - Proof of Singapore passport surrendered to Malaysia Immigration.

This extrajudicial detention is tantamount to "kidnapping" me and waiting for an implicit expectation of something from my family before I can be released.

Upon pressure from my family together with the assistance of the Johor Bahru Consulate General of the Republic of Singapore office, I was finally allowed to be released from Pekan Nanas Immigration Depot on 04.04.2018.

I was then transported back to Singapore supposedly as an illegal immigrant to justify this extrajudicial detention after locking me up against my will from 26.03.2018 to 04.04.2018.

The reason for making this police report for the Royal Malaysia Police to investigate on this illegal and unconstitutional detention. I would then be able to follow up to seek Counsel's advice. I was instructed by one ACP Gurcharan Singh from High Commission of Malaysia to lodge this report in a Singapore Police Station.
