Dear Sir/Madam,

Further to my email dated 22-12-2021 on the status of these four police reports, it has been 21 days since the police reports dated 8-12-2021 were lodged at a Singapore police station in accordance with Mr Gurcharan's instructions.

And today is another 7 days from my last email dated 22-12-2021 to the Malaysia Consular office and there is no acknowledgement of these police reports being lodged with the Royal Malaysian Police (RMP). See attachment #1 for the email acknowledgement by MHC.

From what was being informed by Mr Gurcharan, Interpol would be able to provide a status update after one week of police reports being lodged at Singapore police station. So even when there is no status update from Interpol, there should be some movement in between the second and third week such as what has the RMP done with these police reports? Have the police reports been logged into the RMP's system and when will the investigation commences? Status updates on any movements should be available now.

Why this investigation is important is because I have read about the case of a Nigerian PHD student named Thomas Orhionsefe Ewansiha who died while in immigration's custody. He was arrested and detained on 04-07-2019 even though he had a valid student visa and he ended up dead in immigration depot.

Similarly like this Nigerian national's death that happened inside immigration depot, I could also suffer the same fate while inside immigration depot. I had a heart attack hospital admission in Singapore on 8-8-2018. This heart attack could possibly happen inside the immigration depot if I have been forced to languish for don't-know-how-many months inside the immigration depot. See attachment #2 for my heart attack hospital admission.

It is important to have an impartial police investigation to determine those responsible for my illegal and unconstitutional detention (12-03-2018 to 26-03-2018) and also the extrajudicial detention (26-03-2018 to 04-04-2018).

To be fair to Royal Malaysia Police and myself, only third party independent observers are copied on this correspondence for the purpose of transparency.

An update from the Malaysia Consular office or Mr Gurcharan Singh would be very much appreciated.

Reference to the above request for an appointment at the Malaysia High Commission to make a police report to the Royal Malaysia Police;

It has now been more than three working days without any response from the Malaysia High Commission.

Can the Malaysia High Commission enlighten on the reason for a non-reply?

I will reiterate here that this is a matter of significant importance which warrants your response and action on behalf of the Malaysia Government.

Why is that so? This is so because it pertains to justice and human rights of all foreigners when they are legally allowed in Malaysia.

As you may or may not be aware, I was subjected to the laws of Malaysia where I was put through the Malaysia Judiciary and legal system, whereby the Judiciary extracted a conviction out of me. In order that the Judiciary and the legal system not to be tainted with any miscarriage of justice or travesty of justice;

1. For cases involving foreigners, foreigners must be accorded the right to bring all case-related grievances and injustices to the attention of the Judiciary. This is what I am humbly requesting here.

2. I would also argue that transparency before the public is being fair to all parties (Immigration Department and myself) as I am a non-Malaysian, an "outsider", not one of the same kind.

On this basis, I have copied human rights NGOs, International Commission of Jurists and including the press now as third party independent observers.

All supporting documents and proofs are re-attached for reference.
