I was arrested by Muhammad Hanis with 11 others on the night of 28.02.2018. See Attachment 2 - List of arrested persons

Of the 11 arrested persons, 5 of them were locked in the same cell with me till I was released on the 04.04.2018. Though they were not charged, meaning that they did not commit any offence, yet they were all deported back to their own country which is a matter that should be looked into for the reasons why.

Following after the arrest I was locked up firstly at Setia Tropika Complex, then transferred to Pekan Nanas Immigration Depot. From the time of arrest I was never presented before any Magistrate within 24 hours, also within 7 days, also within 14 days and finally up to the 26.03.2018.

On the morning of 26.03.2018 I was brought before a Magistrate for the first time since I was arrested and locked up against my will. This was for the purpose of charging me for an offence under section 55E(1) of the Immigration Act 1959/63.

After this, my family paid the court fine of RM30,000/- while I was transported to Kluang Prison and I was locked up even though I was given a Court Order of Discharge on the 26.03.2018. After a few days, I was transferred back to Pekan Nanas Immigration Depot and locked up till my release on the 04.04.2018.

This period of detention from 28.02.2018 to 26.03.2018 was illegal and unconstitutional as I was never presented before any Magistrate. This was the verdict given by the KL High Court. See Attachment 1 - KL High Court Judgement.

All the officers named above have taken part in this illegal and unconstitutional detention against my will. This detention is tantamount to "kidnapping" me with the objective of waiting for an implicit expectation of something from my family. An acquaintance whom I knew from a charity organization met Mr Prem Singh to give a testimony on my character and on the 8.3.2018 went to meet my family to discuss a "helpful suggestion". This acquaintance was allowed to visit me on the 9.3.2018.

The reason for making this police report is for the Royal Malaysia Police to investigate on this illegal and
