In paragraph 13 of his affidavit Jawapan Defendan - Muhammad Hanis Bin Kasni (Saman Pemula No: WA-24-5-01/2021, KL High Court), quote: 'Saya sesungguhnya menyatakan bahawa saya telah mengemukakan Plaintif di hadapan Majistret pada 12.3.2018 seleras dengan peruntukan Seksyen 51(5)(b) akta Imigresen 1959/1963 dan Perkara 5(4) Perlembagaan Persekutan" unguote. In the English language, it is translated as "I solemnly state that I have presented the Plaintiff before the Magistrate on 12.03.2018 in accordance with the provisions of Section 51(5)(b) of the Immigration Act 1959/1963 and Article 5(4) of the Federal Constitution. See Attachment 2 - Affidavit Jawapan Defendan -Muhammad Hanis Bin Kasni (Saman Pemula No: WA-24-5-01/2020, KL high Court). In another High Court Proceeding, he had averred in his Affidavit -In-Opposition in paragraph 9 and 10 the following, quote: "para 9: Saya juga sesungguhnya menafikan perenggan 26,27,28 dan 29 Afidavit Sokongan Pemohon. Pemohon telah ditahan mengikut prosedur ditetapkan perenggan 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39 dan 40 Afidavit Sokongan Pemohon. Semetara menuggu untuk siasatan dilengkapkan dan pertuduhan dimulakan, Pemohon telah ditempetkan di Depot Imigresen Pekan Nanas. Sepanjang Pemohon ditahan di sana, sebagai pegawai penyiasat kes tersebut, saya tidak pernah dimaklumkan mengenai apa-apa aduan oleh Pemohon sepertimana dibangkitkan dalam perenggan di atas baik secara bertulis atau lisan. Selain itu sebagai pegawai penyiasat saya juga akan memastikan Pemohon yang merupakan saspek jagaan saya ditahan mengikut prosedur yang ditetapkan undangundang", unquote.

In English language, it is translated as "Para 9: I also solemnly deny paragraphs 26, 27, 28 and 29 of the Applicant's Affidavit of Support. Applicant has been detained in accordance with procedures prescribed by law. Para 10: I further have no knowledge of paragraphs 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39 and 40 of the Applicant's Affidavit-in-Support. While waiting for the investigation to be completed and the charges to be initiated, the Applicant was placed at the Pekan Nanas immigration Depot. Throughout the

Applicant's detention there, as the investigating officer of the case, I have never been informed of any complaint by the Applicant as raised in the above paragraphs either in writing or orally. Apart from that, as the investigating officer, I will also ensure that the Applicant who is a suspect in my custody is detained in accordance with the procedures prescribed by law", unquote. See Attachment 3 - Affidavit Jawapan Responden - Muhammad Hanis Bin Kasni (Permohonan Jenayah No: A-44-178-07/2019, KL High Court)

Muhammad Hasni's Affidavit-In-Opposition is in response to paragraph 40 of my Affidavit-in-Support - Wong Chun Khuen (Criminal Application No./2019, Case No. 62PT-900-03/2018, KL High Court), quote: "On 26/03/2018, after 26 days from arrest, I was first brought before a magistrate. I was charged and I pleaded guilty as I could not afford and risk further detention any longer as already explained above, and I was convicted and sentenced, as already said above." Unquote. Muhammad Hasni averred that he had no knowledge of para 40 of the Applicant's(myself) Affidavit-in-Support which is an inconsistent affidavit by Muhammad Hanis that he had no knowledge as to my statement that I was produced before a magistrate for the first time only on 26/03/2018.
