Thank you for your email.

As lawyers, we don't lodge police complaints or affirm affidavits on behalf of clients. Indeed, such an act will be considered to fall short of professional standards. We only represent clients in litigation, communication and the like.

In any event, I represent the client in the litigations and was authorised only to follow up with the police on the status of his complaint. Accordingly, I won't be able to lodge any complaint on behalf of the client.

However, I feel that there must be a mechanism for an aggrieved person overseas to lodge a complaint, and I much feel that the mechanism must be that the aggrieved person must be that he lodges a complaint in the consular office of Malaysia which should forward it to you for your action. But if there is any other mechanism for an aggrieved person, please let me know so that I can convey the same to my client.

You will appreciate that, indeed a complaint, to carry due weight, must be lodged by someone who has the personal knowledge of the matters.

I will look forward to hearing the mechanism of my client lodging a complaint from Singapore.
