Brief details.

This police report is to make against Harifah Binti Busu, an Immigration officer from the Pekan Nanas Immigration Depot.

In paragraph 17 of her Affidavit, quote: "Saya menafikan perenggan 40 Afidavit Sokongan Pemohon. Pemohon telah dibawa ke hadapan Majistret untuk dilanjutkan tahanannya di bawah Seksyen 51(5)(b) akta Imigresen 1959/1963 pada 13.2.2018 dan dibernarkan sehingga 26.3.2018. Pada 26.3.2018, Pemohon telah dituduh di Mahkamah. Sesalinan perintah oleh Majistret dikemukakan dan ditandakan

sebagai ekhsibit "HB-1", unquote. In the English language, it is translated as "I hereby deny paragraph 40 of the applicant's Affidavit-in-Support. The applicant was brought before the Magistrate for further detention under Section 51(5)(b) of the Immigration Act 1959/1963 on 13.3.2018 and allowed until 26.3.2018, the applicant was arraigned in Court. A copy of the order by the Magistrate is presented and marked as "HB-1". See Attachment 2 - Afidavit Jawapan Responden - Harifah Binti Busu (KL High Court, Permohonan Jenayah No.: WA-44-178-07/2019)

It will be seen that her above averment on oath, Harifah has bought into doubt on her averment as Muhamad Hanis had also similarly averred that he personally brought me before the Magistrate in one of his Affidavit. Since the KL High Court Judgement in paragraph 29 stated as follows: "It is of the considered view that the Plaintiff's (myself) deposition that was not produced before any Magistrate on 12.3.2018 is substantiated by the fact that there are two remand orders which have not been explained off by the Defendant (Muhamad Hanis)", so both Harifah and Muhamad Hanis had potentially lied on oath in their affidavits seemingly based on her Lordship's findings. See Attachment 1 - KL High Court Judgement (dated 23.8.2021 for Saman Pemula No. WA-24-5-01-2020)

This requires an investigation to determine whether Harifah Binti Busu had deliberately lied an oath in her affidavit before Court.

Harifah also presented Exhibit "HB-1" as evidence to support her averment that she had personally brought me before the Magistrate. As it can be seen from "HB-1", this exhibit, "HB-1" that was given by Harifah to the High Court does not have page 3 of 3. This was potentially a deliberate act to hide the truth from Court by hiding away this page3 of 3 which is the Magistrate remand order. The hard copy page 3 of 3 is the same exhibit "W-2" as mentioned in paragraph 27 line 5 of the KL High Court Judgement.
