Her Affidavit Jawapan Defendant (1) is filed for KL High Court Saman Pemula No. WA-24-16-04/2022.

Similarly, Muhd Haris Bin Ismail had also stated in all of paragraph 6 of his Affidavit Jawapan Defendant (2) on 12/07/2022 that he had taken part in confining me from 27/03/2018 to 03/04/2018 in Kluang prison and then in Pekan Nenas Immigration Depot. His Affidavit Jawapan Defendant (2) is filed for KL High Court Saman Pemula No. WA-24-16-04/2022.

Muhammad Hanis is the Investigation Officer named in paragraph 24 of the KL High Court Judgment for Saman Pemula No. WA-24-5-01-2022 dated 23/08/2021. He is one of the officer responsible for my wrongful confinement.

Harifah Binte Busu had stated in all of paragraph 1, 16 and 17 of her Affidavit Jawapan Respondent on 26/08/2019 that she was the commander of Pekan Nenas Immigration Depot and was also responsible (though denied) for my wrongful confinement. Her Affidavit Jawapan Respondent is filed for KL High Court Permohonan Jenayah No: WA-44-178-07/2019.

Mohd Zain Bin Mohd Ali had stated in paragraph 1 and 5 of his Affidavit Jawapan Respondent on 19/09/2019 that he was the supervisor carrying out my wrongful confinement in Pekan Nenas Immigration Depot. His Affidavit Jawapan Respondent is filed for KL High Court Permohonan Jenayah No: WA-44-178-07/2019.
