Dear Supt Saravanan Kanniappan,

Thank you for your email and the attached letter. I am instructed as follows.

However, it seems that the key part of my client's complaint had missed your attention.

The said key part is that my client was detained by immigration officers from 28/02/2018 to 26/03/2014, i.e. about 27 days.

He was not produced before a magistrate until 26/03/2014. Art 5(4) of the Federal Constitution requires the production of any foreigner arrested under immigration laws to be produced before a magistrate within 14 days. Accordingly, the detention for the last 13 days was unconstitutional and illegal.

The KL High Court on 05/05/2021 accordingly declared, upon my client's application, that he was unconstitutionally detained for the last 13 days. The order of the court is attached herewith.

On this basis, among others, my client complained to Interpol that he was illegally detained for the last 13 days. Your letter does not address this illegal detention.

The fact that was convicted of an immigration offence is completely irrelevant to my client's complaint of illegal detention for the last 13 days, as declared by the High Court.

I trust that, with the High Court declaration, there is ample material to justify the investigation of and appropriate action on the complaint of illegal detention for the last 13 days.

It will not make sense for my client to go to immigration to make a complaint against the immigration officers.

I am of the view that the illegal detention of a person (beyond that allowed by the law) is an offence that falls within the scope of PDRM.

My client will expect that you will promptly take due action.
