Sir/Madam,

On 31st October 2022, three Judges of Court of Appeal Malaysia had dismissed the Malaysian Government's appeal (Rayuan Sivil No. W-01 (A)-282-05/2021) with cost awarded to me. This appeal by the Malaysian Government is to challenge the KL High Court 4th May 2021 judgment (Saman Pemula No. WA-24-5-01/2020). This 4th May 2021 judgment declared that my detention from 13 March 2018 to 26-March 2018 by the Malaysian Immigration authorities is unlawful, illegal and unconstitutional. Now four judges (from the Malaysian High Court and Appeal Court) have affirmed the fact that my detention from 13th March 2018 to 26th March 2018 by the Malaysian Immigration authorities is unlawful, illegal and unconstitutional.

According to the Laws of Malaysia: Act 574, Penal Code Section 344 - **Wrongful confinement for ten or more days**

"344. Whoever wrongfully confines any person for ten days or more, shall be punished with imprisonment for a term which may extend to three years, and shall also be liable to fine."

The fact is clear as day that a crime had been committed by officers from the Malaysian Immigration authorities against me. This is evidenced from Judgment Orders, one from Malaysian High Court and a second one from Appeal Court.

A police report had been filed against these officers for this criminal action against me. See attached Police Report L_20211208_2005.pdf.

I attached the instruction by a representative of the Malaysian Government on the protocol of filing a police report to Royal Malaysian Police for person blacklisted for life from entering Malaysia. See attached file - Gmail - Re_ Illegal detention by Malaysia Immigration Officer_ACP.

Please be respectful to JUSTICE and all are equal, regardless of nationality before the same set of law, whether it is Singapore laws or Malaysia laws. Malaysian laws had been used against me and I, being a victim of vicious acts, would expect that the same Malaysian laws would be used against equally all the Immigration officers who had unlawfully and wrongfully confined me for 13 days in inhumane and cruel detention depot environment.
